- The project "TEMPUS (TEMPorary USEs as start-up actions to enhance port (in)tangible heritage, CUP: B74I18000140006 - ID: 10044521, is an European project funded under the European 2014 - 2020 Interreg V-A Italy - Croatia CBC Programme and pertains to the priority axis Environment and cultural heritage.
- TEMPUS aims at promoting a new economic development based on the valorization of the hidden tangible and intangible port heritage, including archaeological and natural assets, through the start-up of Temporary Uses Actions (TUAs). The project aims to leverage the variegated and peculiar legacy of urban ports in the Adriatic and the untapped potential of local communities through their direct involvement in the definition and launch of urban strategies. To this extent, TEMPUS will implement an integrated set of TUAs, focused on the idea of urban ports as melting pots of traditions, histories, activities, architectures, and cultures, which will allow creating new contextual values to be capitalized for triggering wider scale CR Valorization and Regeneration Processes.
- Within TEMPUS, integrated Port Cities Urban Strategies (PCUS) are devised, aiming at describing how Temporary Uses can be exploited to experiment on the potential of the Cultural Heritage, while bringing new impulses to the local Cultural and Creative Industries (CCI) sector, in order to reach the definition of a valorisation plan. It is a not-planning document, aimed at paving the way for the coordinated effort of public and private actions following a clear long-term vision, in which the Temporary Uses Action (TUA) is considered the first and trigger step. Co-designed thanks to the collaboration of the LAG work group, the strategy is conceived to cover a long-time span, as guaranteed by the subscription of the present statement.
